The placement student will attend our Wilberforce Academy, which is an initiative of Christian Concern.

The Academy is a 1 week residential intensive equipping Christians in cultural apologetics and Biblical worldview. In addition to the 5 days of teaching, there are a further 3 teaching days during the year. The rest of the placement will be made up with a research article or reflective essay to be agreed between the supervisor and the student.
