We communicate God's truth in public debate, especially in the media, politics and law. We campaign on various issues. We give interviews on TV and radio and we are quoted in newspapers and online news sites. We engage with government policy, and we work with parliamentarians and public officials. We use our legal, policy and media expertise to seek justice and protect the vulnerable. The placement student will attend our Wilberforce Academy, which is an initiative of Christian Concern. The Academy is a 1 week residential intensive equipping Christians in cultural apologetics and Biblical worldview. In addition to the 5 days of teaching, there are a further 3 teaching days during the year. The rest of the placement will be made up with a research article or reflective essay to be agreed between the supervisor and the student.
